I understand and agree that neither Coco View Resort, Roatan Charter, Dockside Dive Center, nor any of their affiliates or subsidiary corporations, nor any of their respective employees, officers, agents, contractors or assigns (hereinafter referred to as 'Released Parties') may be held liable or responsible in any way for any injury, death or other damages sustained by me, my family estate, heirs or assigns that may occur as a result of my participation in the recreational activities referenced above as a result of the negligence of any party, including the Released Parties, whether passive or active.

I agree that any lawsuit filed against the Released Parties by me or by a representative of my estate shall be filed in Honduras, S.A. and the rights of any parties to that lawsuit shall be decided under the law of Honduras, S.A.

I understand and agree that I am not only giving up my right to sue the Released Parties, but also any rights my heirs, assigns or beneficiaries may have to sue the Released Parties resulting from my death. I further represent I have the authority to do so and that my heirs, assigns or beneficiaries will be estopped from claiming otherwise because of my representations to the Released Parties.

I, ______, BY THIS INSTRUMENT AGREE TO EXEMPT AND RELEASE THE RELEASED PARTIES, AND ALL RELATED ENTITIES AS DEFINED ABOVE, FROM ALL LIABILITY OR RESPONSIBILITY WHATSOVER FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH, HOWEVER CAUSED, INCLUDING, BUT NOT LIMITED TO, THE NEGLIGENCE OF THE RELEASED PARTIES, WHETHER PASSIVE OR ACTIVE.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THE LIABILITY RELEASE AND ASSUPTION OF RISK AGREEMENT BY READING IT BEFORE I SIGNED IT ON BEHALF OF MYSELF AND MY HEIRS.
